LIMITED WARRANTY

2/1/2025

GM Lighting - Irradiar Landscape Lighting

GM Lighting warrants to the first non-dealer purchaser of Irradiar Landscape Lighting products that they are to be free from defects in material and workmanship for the period stated below from the date of purchase for all above grade lighting fixture products.

Landscape Luminaire, brass accessories	10 YEARS
Stainless Steel Transformers without controls	10 YEARS
Transformers with built-in timers	5 YEARS
120V Controls	5 YEARS
MR, PAR lamps	5 YEARS
G4 lamps	3 YEARS
Accessories, non-brass accessories, wire, connectors	5 YEARS

Irradiar Landscape Products (as defined by products offered at www.gmlighting.net) carry a 10-year warranty on low voltage electronics, 5 years on 120V electronics, 10 years on outdoor finishes on brass fixtures, under normal use.

Although GM Lighting uses the best available materials and does extensive testing for finish endurance, some fading or chalking may occur and is considered normal. For Irradiar Landscape Products, “normal use” requires regular cleaning and maintenance of the exterior of the products to prevent permanent fading or corrosion. For coastal locations, some corrosion and/or deterioration is considered “normal wear” in this environment. Therefore, any finish claim due to coastal environment conditions is not applicable to our warranty.

If a product is defective, all efforts will be made to correct the problem in the field. If the problem cannot be resolved, an RMA number will be issued. GM Lighting’s obligation is expressly limited to repair or replacement, without charge, at GM Lighting’s factory after prior written return authorization has been granted. GM Lighting’s obligation under this warranty shall not extend beyond the distributor’s initial purchase price of the product and accordingly any consequential or collateral damages or labor costs arising out of a defect are expressly excluded.

This warranty shall not apply to products that have been altered, improperly installed, mishandled, misused, stored or used in excessively humid or hot conditions for an extended period, have not been installed in accordance with the installation instructions and warnings therein, damaged due to neglect (including but not limited to improper maintenance), repairs or modifications (including but not limited to use of third-party components), and/or any causes outside of GM Lighting’s reasonable control (e.g., acts of God). Notice of a defect in writing must be received by GM Lighting within the published warranty period from the date of purchase (or according to period of time as outlined by material). Excluded from warranty are any 3rd party component which carries its own manufacturer’s warranty. Note: GM Lighting product warranty applies only to purchases from authorized GM Lighting distributors.

ENGINEERING CHANGES:

GM Lighting retains the right to modify the design and specifications of our products at any time as part of the company’s continuous improvement program.
